IMPORTANCE Blending citizen and traditional media creates a fuller, more democratic media landscape that supports truth-telling and community empowerment.

DEFINITION <u>Citizen journalism</u> refers to reporting done by ordinary individuals — often using smartphones, blogs, or social media — outside of institutional newsrooms. Traditional media involves

professional journalists working under established news organisations with formal editorial oversight. Strengths include fast, raw and direct from the source and builds local trust.



IMPORTANCE In fragile peacebuilding contexts, falsehoods can escalate tensions—fact-checking promotes trust, stability, and

EXAMPLE The Démagog initiative in Poland trains youth to spot fake headlines, manipulated videos, and emotional misinformation across TikTok and Instagram.

DEFINITION Fact-checking verifies claims made in media and public discourse. It's essential for preventing false information from spreading, particularly in conflict-sensitive or fast-moving situations.

CONCEPT Digital Security & Ethical

Reporting: Protecting journalists and sources. Best practices for journalists and content creators.



IMPORTANCE Citizen reporters are often first on the scene. Ensuring their safety and ethical standards protects lives and the credibility of peace journalism.

EXAMPLE Witness trains activists globally to film human rights abuses safely, guiding them on consent, storage, and how to avoid endangering victims.



DEFINITION Digital security means

protecting personal data, communications, and identities — particularly critical for journalists working in repressive or risky environments. Ethical reporting includes responsible handling of sensitive content.

Use encrypted messaging Apps (e.g., Signal). Blur faces or names in sensitive conflict photos. Store files securely (e.g., Tails OS or encrypted USBs)



IMPORTANCE When communities tell their own stories, they reclaim identity, promote dignity, and break cycles of fear and marginalisation — promoting and enabling resilience and unity.

DEFINITION Community-led media refers to grassroots initiatives where locals produce and share content relevant to their lives — often as a tool for inclusion, advocacy, and social cohesion.

EXAMPLE Media Initiatives Center (Armenia): Supports youth from opposing ethnic groups to co-create peace videos and animations

What is citizen journalism?

Citizen journalism refers to the act of everyday people (non-professional reporters) using digital tools, like smartphones, blogs, or social media, to report news, document events, or share stories from their own communities.

It democratises media production and puts storytelling power in the hands of people closest to the issues.

This grassroots approach **empowers communities** to share their narratives, particularly in areas where mainstream media may be absent or biased.





The Evolution and Impact of Citizen Journalism



The roots of citizen journalism can be traced back to the early days of the internet, when blogs and online forums first gave people a platform to share their thoughts and experiences. While citizen journalism has many advantages, it also faces several challenges:





Bultoo Radio (India): An initiative by CGNet Swara, Bultoo Radio uses Bluetooth technology to disseminate news and stories in media-dark zones of Chhattisgarh, India. It empowers tribal communities to share local issues and cultural narratives without relying on internet connectivity. This unique radio station acts as a vital lifeline, spreading information, enabling connection, and empowering these marginalised communities.



On Our Radar

Underpinning all of our work is a diagnostic tool called the 5Cs. There are five recurring barriers that marginalised communities around the world face when trying to share their insights and concerns. This framework offers a pathway for communities to identify and overcome those challenges and share their experiences with dignity and power.



Conviction

Do participants trust you? Are they on board with the aims of the project? Do they believe that speaking out will result in meaningful change?



Capacity

Do participants have the skills, access and resources required to report on a story safely, securely and accurately?



Craft

Do participants have the necessary technical skills to deliver media that is of broadcast quality or ready to be shared internationally on digital platforms?



Connectivity

Do participants have barriers to digital engagement and, if so, what tools are they using already to communicate?



Confidence

Where does the power come from to find your voice?

As technology continues to evolve, the future of citizen journalism looks promising. Several trends are likely to shape its development:

Increased Integration with AI: Artificial intelligence and machine learning can assist in verifying information, curating content, and detecting fake news. These technologies can enhance the credibility and efficiency of citizen journalism.

Greater Collaboration: We can expect more collaboration between citizen journalists and traditional media, leveraging the strengths of both to provide comprehensive and reliable news coverage.

Enhanced Tools and Platforms: Continued innovation will lead to the development of more sophisticated tools and platforms for citizen journalists. This includes better mobile apps, enhanced live-streaming capabilities, and more user-friendly content management systems.

Global Reach: The global nature of the internet means that citizen journalism will continue to transcend borders, allowing people from different parts of the world to share their stories and perspectives.

The impact of decentralised media on trust and information credibility.

Decentralised media refers to information platforms and content that are not controlled by a single gatekeeper, like a traditional news outlet or government, but instead come from many sources: individuals, grassroots groups, independent networks, and digital collectives. This includes platforms like blogs and vlogs, independent podcasts, decentralised social networks (e.g., Mastodon), citizen journalism platforms (e.g., Wikinews), blockchainbased or peer-to-peer media tools (e.g., Mirror.xyz, DTube)

Unlike mainstream media, decentralised news sources allow multiple perspectives, but they also require credibility checks. <u>UNESCO: Media and Information</u>

Why it Matters. The impact of decentralised media on trust and information credibility.





Decentralised media allows *anyone* to publish, share, and report—especially voices left out of mainstream narratives (e.g. youth, minorities, activists).

Challenges Monopolies on Truth and Narrative Framing
It disrupts the narrative power held by traditional outlets, encouraging accountability and new perspectives.

BUT — Increases Risk of Misinformation – Lack Editorial Oversight Without strong editorial or fact-checking mechanisms, false or manipulated content can spread easily. This can erode trust and fuel division.



Why it Matters. The impact of decentralised media on trust and information credibility.



For mediation and peacebuilding, decentralised media opens up inclusive digital storytelling as a form of conflict prevention and recovery. Youth can become mediators of truth and trust by:

- → Curating credible community content
- →Using peer networks for **fact-checking**
- → Promoting **digital literacy** in their schools or organisations
- →Countering hate or bias with counter-narratives

Dual Impact on Peace and Credibility



Positive Potential

- → Enables **bottom-up storytelling** and digital peace activism
- → Strengthens community trust through localised media voices
- → Enables **resilience and solidarity** through hyper-local narratives
- → Supports rapid mobilisation for peace or solidarity campaigns




Challenges

- → No shared standards for factchecking or journalistic ethics
- → Can amplify conspiracy theories or polarising rhetoric
- → Echo chambers form, reinforcing only one worldview
- → Increases difficulty in verifying source credibility in crisis settings







Grassroots reporting—often led by citizen journalists, activists, or local youth—can powerfully amplify community voices, expose injustice, and spark change. But because it's usually informal, under-resourced, and emotionally close to the issue, it also presents ethical risks and dilemmas. Citizen journalists face risks related to misinformation, privacy concerns, and political pressure.

What Does Ethics Mean in Grassroots Journalism? Ethical grassroots reporting means sharing stories in a way that is accurate, respectful, safe, and socially responsible. It includes telling the truth without causing harm, respecting privacy, especially in conflict zones, avoiding bias, hate speech, or manipulation and ensuring the dignity of the people being reported on

CHALLENGES WITH SOLUTIONS



- → Challenge: Interviewees may not fully understand how their stories will be used online or may feel pressured to share sensitive experiences.
- → Solution: Use Verbal & written consent templates. Informed consent protocols, provide examples of where their story might appear, and allow withdrawal at any stage. Use WITNESS Ethical Interview Checklist

project in Slovakia includes a pre-recording workshop to discuss digital risks and data ownership before filming any testimony.




CHALLENGES WITH SOLUTIONS

- → Challenge: Grassroots reporters may unintentionally spread misinformation due to lack of formal training or reliance on hearsay.
- → Solution: Learn basic fact-checking, cross-verification, and sourcing. Or use peer fact-checking groups. Use platforms like Spotlight or Correctiv for collaborative verification models.

CHALLENGES WITH SOLUTIONS



- → Challenge: Stories may reinforce stereotypes or "poverty porn" if not told with dignity and care.
- → Solution: Encourage participatory storytelling that gives people agency to shape their narrative. Use eyeWitness to Atrocities App and help you make your make your footage a powerful tool for justice the right way.

CONSIDERATIONS Safety and Reprisals



CHALLENGES WITH SOLUTIONS

- → Challenge: Reporting on injustice, war, or corruption can expose citizen journalists to harassment, violence, or legal threats.
- → **Solution**: Use anonymity, encryption, and protective networks like <u>Forbidden Stories</u>, which continue the work of threatened or murdered journalists. Use anonymity, VPN use, digital security training.



Forbidden Stories - Secure Information

Forbidden Stories: Forbidden Stories is an international network of journalists committed to continuing the work of reporters who have been silenced through threats, imprisonment, or murder

- → Collaborative Investigations: Works with global media partners to publish stories that others tried to suppress.
- → SafeBox Network: Provides a secure platform for journalists to store sensitive information, ensuring their work can continue if they are unable to do so.




Case Study: Forbidden Stories Journalist Network

We are a collaborative journalism network devoted to pursuing the work of silenced reporters around the world.

All around the world, journalists are silenced through violence, threats and imprisonment because what they were investigating was known to have potentially far-reaching repercussions.

As a media organisation, we believe news stories are of global significance, we have uncovered critical information on issues such as environmental crimes, corruption, organised crime, drug trafficking, disinformation, cybersurveillance, and human rights violations.


Digital tools and platforms that empower citizen journalists

Citizen journalism involves the collection, analysis, and dissemination of news and information by the general public, often through digital platforms and tools. It enables non-professional reporters to document and share stories, particularly in areas where mainstream media may be absent, biased, or restricted.

Digital tools and platforms empower these citizen journalists by giving them the means to record, edit, publish, and verify content—from social media to decentralised archives, mobile journalism apps, and collaborative reporting spaces. For example, mobile apps and open-source platforms make it easier for individuals to report and share stories securely.



Digital tools and platforms that empower citizen journalists




- Digital media tools aren't just tech—they're a means of participation, protection, and peacebuilding.
 They:
- 1 Empower youth to become agents of change
- 2 Bridge divides through storytelling and shared learning
- Build skills that promote inclusion, critical thinking, and resilience

Case Study: eyeWitness App a Powerful Tool for Media and Justice

eyeWitness to Atrocities: Developed by the International Bar Association, the eyeWitness to Atrocities app enables users to capture photos and videos that can serve as verifiable evidence in legal proceedings.

This app turns war crime footage into legally admissible evidence

- → Accountability: Provides a tool for documenting human rights violations, aiding in the pursuit of justice.
- → **Empowerment:** Equips individuals in conflict zones with the means to safely report atrocities.



Case Study: eyeWitness App a Powerful Tool for Media and Justice

- → Metadata Embedding: Automatically records GPS coordinates, date, time, and device information to authenticate media.
- → Secure Storage: Uploads encrypted files to a secure server, maintaining the chain of custody for legal admissibility

Why Digital Media and Tools Matter in Peacebuilding and Mediation





REASON Fills the Gaps Left by Traditional Media



Empowers citizens to document events directly and share urgent stories



WHAT IT MEANS Mainstream media often overlooks conflict zones, marginalised communities, or grassroots peace efforts—especially in remote or politically sensitive areas. Digital tools empower ordinary people to document events in real time using mobile phones and video apps. Share lived experiences that offer more authentic and diverse perspectives

EXAMPLE In Ukraine, local citizens used Telegram and Signal to share alerts and document bombings when traditional news sources were blocked.

Why Digital Media and Tools Matter in **Peacebuilding and Mediation**





REASON Give Voice to the Marginalised

Amplifies stories of refugees, youth, minorities







WHAT IT MEANS Digital storytelling becomes a **healing and advocacy** tool. People from underrepresented backgrounds—youth, women, ethnic minorities, refugees—can reclaim narratives about their lives and communities.

EXAMPLE Helps reclaim narratives, raise awareness, and reduce stereotypes

REASON Combats Misinformation and Hate Speech

Counters disinformation online





WHAT IT MEANS Social media is often used to spread fear, hate, or disinformation. But the same platforms can be used to:

- → Fact-check. Promote verified narratives
- → Challenge harmful stereotypes with real stories and empathy

EXAMPLE Migrants of the Mediterranean publishes audio testimonies from refugees to counter fearbased migration rhetoric.

REASON Builds Cross-Border Understanding

Facilitates dialogue across cultures and regions





WHAT IT MEANS Promotes empathy, shared goals, and peacebuilding collaboration.

Digital platforms remove geographical and cultural barriers. They allow: Youth from different backgrounds to co-create peace messages. Dialogue across conflict lines via online forums, closed groups, and virtual exchange platforms.

REASON Enables Safe and Anonymous Reporting

Ensures protection in hostile environments





WHAT IT MEANS Allows whistleblowers and peace reporters to share safely. In conflict zones or authoritarian settings, safety is a major barrier to reporting. Digital tools provide:

Encryption (e.g., Signal, eyeWitness to Atrocities)
Metadata tagging for authenticity
Anonymous publishing (e.g., Forbidden Stories,
Bellingcat methods)

REASON Enable Digital & Media Literacy

Builds **critical 21st-century** skills in youth





WHAT IT MEANS Prepares learners for advocacy, employment, and civic engagement. They can develop real-world competencies; such as critical thinking, responsible content creation, ethical journalism, fact-checking and cross-verification. These are essential not only for employment but for active citizenship and democratic resilience


EXAMPLE Use Mural to brainstorm peace messaging, Canva to create infographics, and YouTube to publish digital stories.

Citizen Journalism & Truth Storytelling

Mobile Journalism (MoJo) apps like StoryMaker or Collect. KoboToolbox Collect is a Powerful and intuitive data collection tools to make an impact. A data collection, management, and visualisation platform used globally for research and social good. Our mission is to support open-source data systems and technology for humanitarian action, development, environmental protection, peacebuilding, and human rights.




How to Apply the Tools: Capture and edit community stories using mobile devices. Train locals in basic phone filming + storytelling. Ensure consent and safety of subjects.

Citizen Journalism & Truth Storytelling

YouTube: Publish video stories for a wide audience. Use subtitles and tags for accessibility and reach. Moderate comments to prevent trolling


SoundCloud: Share community radio, spoken word, or oral histories, conflicts, and personal stories. Encourage underrepresented voices to speak and publish. Ensure hosts and voices feel safe from online abuse.



Ethical Considerations in Grassroots Reporting

Eyewitness to Atrocities (by eyeWitness)
Allows secure, time-stamped capture of human rights abuses with metadata. Ideal for conflict settings or marginalised voices documenting violence. Use only in secure, trained environments to avoid harm to reporters

KineMaster / InShot. Edit videos ethically by allowing blurred faces, voice distortion. Apply these when working with vulnerable populations. Do not manipulate context or scenes that could mislead



Decentralised Media on Trust & Information Credibility

Mastodon / Fediverse platforms Share local news in federated environments not controlled by large corporations. Curate trusted networks and hashtags. Be careful misinformation may still spread if moderation is weak.

Correctiv's CrowdNewsroom. Enables collective investigations and publishing from the community. Used for fact-checking decentralised or local news claims. Ensure that the data collected is verified and responsibly analysed






"Who Do You Trust?"

Build critical thinking around trust in decentralised media.

- Learners select **three news stories**—one from mainstream media, one from a blog or influencer, and one from a collaborative citizen news platform (like Wikinews).
 - **Analyse** each using criteria:
 - 1. Who is the author?
 - 2. Are sources verified?
 - 3. What emotions does the story evoke?
 - 4. Could this be misinformation?
- **Discuss:** How does decentralised media affect trust? What standards should citizen media follow?



"Build Your Ethical Toolkit"


Instructions: In small groups, learners role-play as grassroots journalists covering a sensitive issue (e.g., migration, minority rights, conflict recovery).

They must:

- 1.Design a consent form
- 2.Draft a narrative outline using ethical principles
- 3. Present a safety plan

Outcome: Understand the real-life complexity of ethical dilemmas and learn how to apply digital media responsibly.

"Voice from My Street" – A Digital Storytelling Exercise



Step 1: Identify a Story

Ask learners to reflect on a recent event or personal/community experience related to conflict, inclusion, or misunderstanding. It could involve:

- → A local misunderstanding that was resolved.
- → A community initiative promoting peace.
- → An incident of exclusion, discrimination, or solidarity.

Step 2: Research & Record

Participants will gather the basic facts and/or interview 1–2 people (with consent). This can be written, audio-recorded, or filmed (using phones or the <u>eyeWitness to Atrocities</u> app where relevant).



They use one of the following formats:

- → Written blog post (300–500 words)
- →Short video report (1–3 minutes, using tools like InShot or Canva Video Editor)
- → Photo essay with captions
- →Instagram-style story carousel explaining the story visually

Step 4: Reflection and Ethical Check


Learners complete a short reflection worksheet:

- → Did you gain consent to share this story?
- → Is your story fair and respectful?
- →Does it support understanding, not blame?

Step 5: Share or Submit

Participants share their pieces in a virtual classroom gallery (e.g., Padlet or Moodle), or present to peers in a digital "peace pitch" session.





"EyeWitness to Atrocities App"

EyeWitness to Atrocities is a free mobile app developed by the International Bar Association. It helps citizen journalists, activists, and witnesses capture verifiable photos and videos of human rights violations and securely store and share them with legal bodies or media without compromising their safety.

This tool **bridges grassroots truth-telling with legal accountability**, supporting ethical and secure reporting from conflict-affected areas.

Activity: "Reporting What Matters - Using EyeWitness as a Peace Media Tool"

Learners will explore how EyeWitness supports grassroots media, then simulate its use by creating a responsible citizen journalism scenario (no real violence required).

Scenario Creation (20 min)

In pairs or small groups, learners choose or imagine a peacebuilding or social justice issue (e.g., police harassment at a protest, unfair eviction, water contamination, or peaceful resistance). They:

- → Describe what would need to be documented.
- → Plan how to report it ethically and responsibly using the EyeWitness tool.
- → Consider risks and how they would manage them.






- **3** Ethical Journalism Reflection (15 min)
 - → What ethical concerns arise? (e.g., consent, retraumatisation, safety)
 - → How does the app help mitigate these risks?
 - → How could it be misused—and how to prevent that?

Tip: You don't need to use the real app in class (though learners can download it). Use it to spark critical conversations and design thinking. This activity is great for youth who may want to advocate for their communities using technology safely and credibly.










